Your application was selected for review in a process called "Verification." In this process, Carroll College will be comparing information from your application with signed copies of your and your parent(s)' 2008 Federal tax forms, or with W-2 forms or other financial documents. The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, Carroll College will make corrections electronically and notify you in writing.

Complete this verification form and submit it to the Carroll College Financial Aid Office as soon as possible, so your financial aid won't be delayed. Our office will be glad to assist you.

Verification must be completed no later than 14 days prior to the end of the first semester of enrollment. Failure to complete verification will result in the cancellation of all federal and institutional need-based aid. In addition:

- No federal loan(s) will be released until verification is completed.

- Students employed under the federal work-study program cannot work more than 60 consecutive days from the beginning of the semester without completing verification.

What you should do

- Collect your and your parents(s)' financial documents (signed Federal income tax forms, W-2 forms, etc.).
- Talk to the Carroll Financial Aid Office if you have questions about completing this worksheet.
- Fill in and sign the worksheet—you and at least one parent.
- Submit the completed worksheet, tax forms, and any other documents Carroll College needs.
- Carroll College will compare information on this worksheet and any supporting documents with the information you submitted on your application.

Carroll College must review the requested information, under the financial aid program rules (34 CFR, Part 668).
