

# 2024-2025 IDENTITY & STATEMENT OF EDUCATIONAL PURPOSE FEDERAL STUDENT AID PROGRAMS

Your application was selected for review in a process called "Verification." In this process, Carroll College will be comparing information from your application with your educational records (if necessary), as well as your and your parents' financial documents. The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, Carroll College will make corrections electronically and notify you in writing.

Verification must be completed no later than <u>the first day of class</u>. Failure to complete verification will result in the cancellation of all federal aid. In addition:

- No federal loan(s) will be released until verification is completed.
- Students employed under the federal work-study program cannot work more than 60 consecutive days from the beginning of the semester without completing verification.

Carroll College must review the requested information, under the financial aid program rules (34 CFR, Part 668)

## Identity and Statement of Educational Purpose (To Be Signed at the Institution)

The student must appear in person at <u>Carroll College</u>, 1601 North Benton Ave, <u>Helena</u>, <u>Montana</u>, 59625 to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or U. S. passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed and the name of the official at the institution authorized to collect the student's ID.
