Carroll is a place where a **higher standard** is almost tangible;



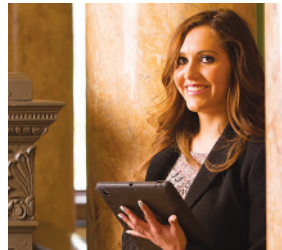
where students transform and thrive in an **opportunity-rich location** surrounded by the beauty of God's creation;

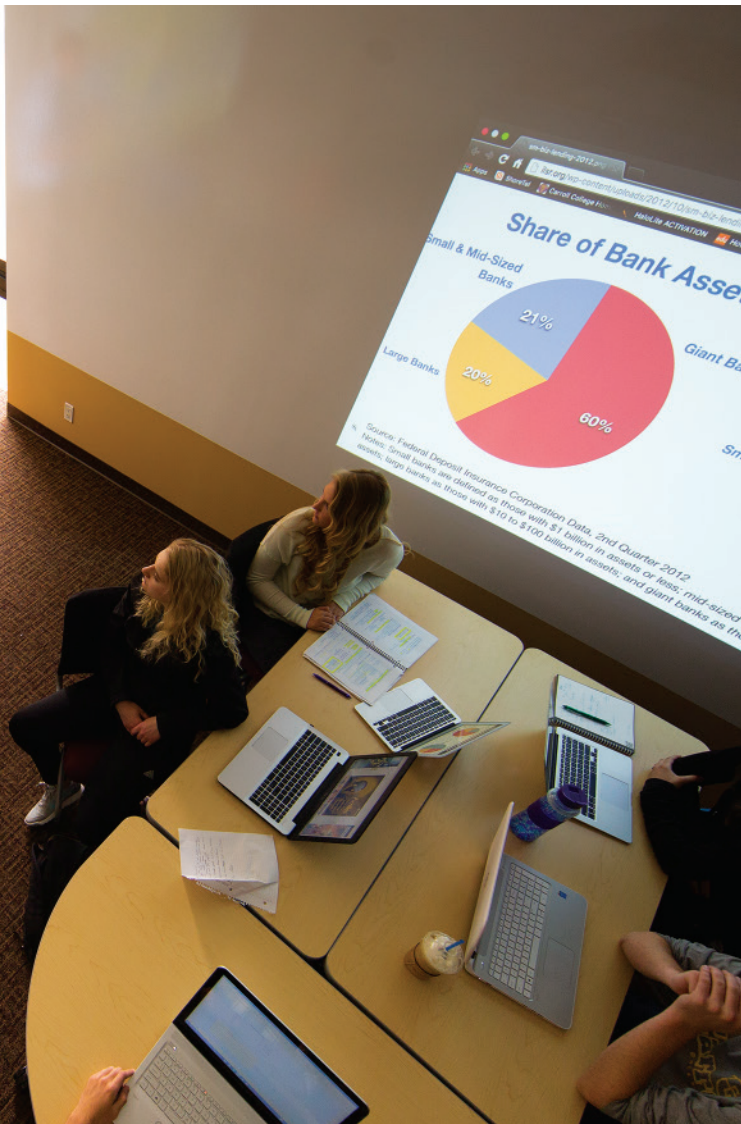
The Legacy Society honors donors who have made a planned gift to Carroll College through trust, bequest or other estate plans. These gifts were made prior to July 1, 2016.

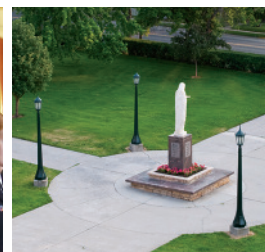

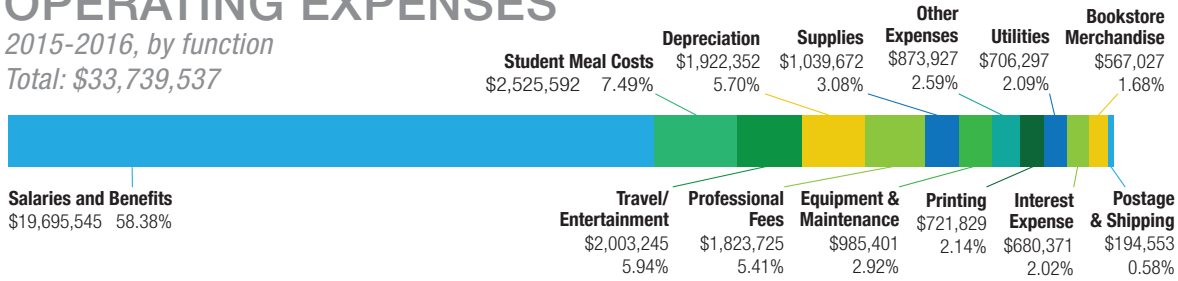

Total: \$33,739,537



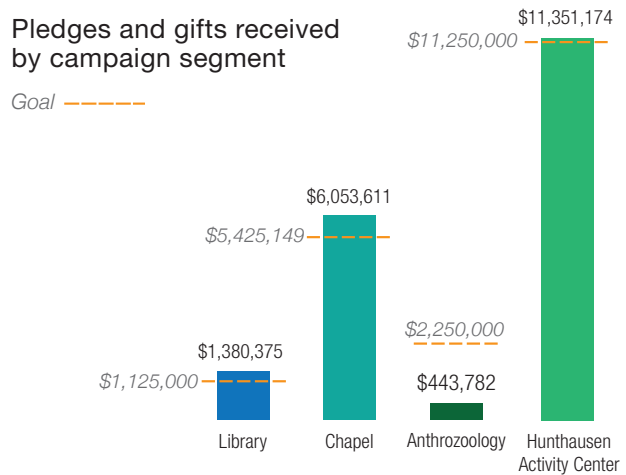

## ALL REVENUE SOURCES 2015-2016

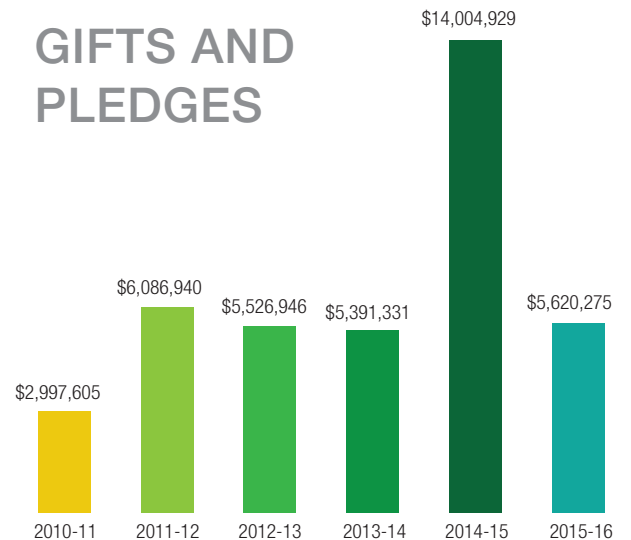
Investment Income
